**2. JURISDICTION :**


Jurisdiction of the Association shall be limited to the whole of Maharashtra.

**4. MEMBERSHIP AND ENROLLMENT OF MEMBERS:**


- Any person who shall ex-student, teaching, non-teaching, technical staff of the concerned department only be eligible to become a member of the Association.

The membership of the member of Association will be cancelled for following reasons.


- A. If he moves out of the jurisdiction of Association.

8. **NOTICE AND QUORUM OF THE GENERAL BODY MEETING :**



- B. President-1, Vice-President-1, Secretary-1, Joint-Secretary-1, Treasure-1 and all others shall be the members of the Executive Committee.


