## MEMORANDUM OF UNDERSTANDING

Between

CSMSS Ayurved Mahavidyalaya-Rugnalaya, Aurangabad

&

Jivanbai Tapadia Charitable Trust's Matoshree Vridhasharam,  
Nakshatrawadi, Aurangabad.

This Memorandum of Understanding (MOU) is entered into on this 24<sup>th</sup> day of September, 2018 by and between CSMSS Ayurved Mahavidyalaya-Rugnalaya, Aurangabad and Jivanbai Tapadia Charitable Trust's Matoshree Vridhasharam, Nakshatrawadi, Aurangabad, and both the parties agree that cooperation would be mutually beneficial for both Vridhasharam & Institute. The areas of cooperation may include, subject to mutual consent, any desirable and feasible activity that would further the goals of each institution. Such interaction may include cooperation in a variety of joint academic and educational activities along with medical facilities such as:

- Free Medical health checkup for patients every week at Matoshree Vridhasharam, Nakshatrawadi, Aurangabad.
- Supply of free Medicines in the above camp.
- Free Pathological & Radiological (X-ray, Sonography) investigations at CSMSS Ayurved Mahavidyalaya-Rugnalaya, Aurangabad.

- Free emergency medical treatment for needy patients at CSMSS Ayurved Mahavidyalaya-Rugnalaya, Aurangabad.

- Free diet & Yoga counselling camps.
- Free admission & free diet at CSMSS Ayurved Mahavidyalaya-Rugnalaya, Aurangabad for needy patients.
- Visits by faculty, professional staff, and students.


The parties anticipate that a number of these initiatives will occur during the period of this MOU. However, neither party is obligated to agree to any minimum number of activities, nor is this MOU intended to preclude either party from entering into similar agreements with other institutions.

This MOU shall be identified as the parent document of any program agreement executed between the parties. Further agreements concerning any program shall provide details concerning the specific commitments made by each party and shall not become effective until they have been reduced to writing, executed by the duly authorized representatives of the parties.

For agreed upon activities, both institutions will make available their facilities and staffs. This MOU will take effect on and will be valid for Ten (10) years from the date noted in the first line of this document unless terminated by one of the parties. Either party may withdraw from this MOU provided written notification of the withdrawal is given to the other party at least three (3) months prior to the desired withdrawal date. This MOU may be renewed for another period of three (3) years upon mutual written consent of the parties before the expiration date. Each institution will have copies of this agreement.
